Dear Wills Point Business Owners:

2017 Wills Point, Texas BRICK\$ BUCK\$ - SHOP LOCAL PROMOTION MERCHANTS RULES AND INFORMATION SHEET

- 1. Participants will receive one roll of tickets (2000 in a roll) with the initial registration fee. Additional tickets can be ordered for \$20 per roll.
- 2. Tickets can be delivered to your business on or before October 27, 2017.
- 3. Persons must be at least 18 years of age to win. Must be born before 12/9/1999.
- 4. Ballot boxes with signage will be provided to all participating businesses for tickets.
- 5. Tickets will be verified. The Program Coordinator and the Accountant are the sole source of tickets to be used in the promotion.
